- in general procedure
 - minister of religion / non / monk

 - accredited journalist
 - teacher
 - research activities / lecturer
 - a right to take employment, arising from treaty (*include a reference to the relevant provision of the treaty*)

 - intra-corporate transfer employee
 - babysitter-housemaid
